

ECOS VAN CONTRACT

1. The van is rented on a first come, first serve basis. However, final decisions are at the discretion of the Office of Campus Activities. Vans are to be parked and picked up in **Edmundson Lot**.
2. Gas cost is the responsibility of the person checking out the van. The van is to be returned with a **full tank** of gas. The receipt of gas charges must accompany the key within the drop box. Failure to do so will result in a charge of **\$10**, in addition to the price of gas.
3. If the situation arises where a student, staff or faculty member receives the van or vans where the fuel tank is not full they will be reimbursed the difference whereas the party responsible for not filling the fuel tank will be billed the difference and charged a **\$15** service charge.
4. Any damage caused to the van while in the possession of the organization/department will be considered their sole responsibility as well as the costs and repairs as deemed by Campus Activities.
5. The use and/or transportation of alcohol and drugs while in possession of the van are strictly prohibited. Violation of the rule will result in an incident report to be filed with Campus Safety. The proper authorities will also be notified.
6. The van must be returned on time with a **full tank** of gas. Failure to return the van on time will result in additional charges. The keys must be turned in at the determined time. A charge of **\$20** is applicable if the van is not returned on time.
7. In the event that the van is returned unclean and/or the seats are removed and not replaced the club, organization or department will be charged a **\$20** service fee.
